The Rescue Mission's Skills for Success Program, which is a multi-agency collaboration between MVCC Youth Build, Oneida - Madison County BOCES Career & Technical Education Program and the HomeOwnershipCenter, is scheduled to complete the construction of a small home in 2020. WHO MAY QUALIFY?

- Those who do not presently own a home or real property
Those who successfully complete and comply with Financial Coaching Sessions provided by the HomeOwnershipCenter and have adequate financial resources/financial plan to be able to maintain the home
Those who have participated or are participating in one of the following programs:
Rescue Mission of Utica Programs: Emergency Shelter, Parker House Aftercare Program, West Street Apartments, Enriched Living Center, Addiction Stabilization Center
The Emmaus House of Utica
MVCC: Building & Trades Program, participated in or is participating in the construction of Home
MVCC: Youth Build Program, participated or is participating in the construction of Home

OR

Those who are a United States Veteran as defined by Title 38 of the Code of Federal Regulations currently residing in Oneida County

- The Primary Applicant must sign the Consent for Release and Exchange of Confidential Information Form.
The Household must meet below income criteria:

- 1 Person Household - Yearly Household Income must be between \$22,000 and \$37,000
2 Person Household - Yearly Household Income must be between \$28,000 and \$43,000
3 Person Household - Yearly Household Income must be between \$31,000 and \$49,000
4 Person Household - Yearly Household Income must be between \$35,000 and \$54,000

Family size at the time of the application is limited to four persons (including children) occupying the home due to the size of the home

AFTER YOUR APPLICATION HAS BEEN COMPLETED & VERIFIED:

A referral will be made to the HomeOwnershipCenter, located at 1611 Genesee St., Utica, NY. You must successfully complete and comply with Financial Coaching at the HomeOwnershipCenter. If you meet all the requirements such as affordability and credit requirements, this will allow you to be an eligible candidate for a Rescue Mission Small Home. Please note applications will be processed and verified by the Rescue Mission on a first come, first serve basis. If more applications are received and verified than there are Financial Coaching slots available, a waiting list will be created.

AFTER COMPLETION OF THE HOMEOWNERSHIPCENTER FINANCIAL COACHING SESSIONS:

Once the Financial Coaching Sessions are successfully completed the HomeOwnershipCenter will refer you back to the Rescue Mission. The new owner of the Small Home will be randomly selected from the individuals that successfully complete the HomeOwnershipCenter Financial Coaching Program and meet income/credit qualifications.
